Why Committees Are Important

Drug Caucus

The Senate Drug Caucus has general oversight on international and other drug issues that affect us, and we have worked closely with them over the years as champions for the ONDCP and the DFC program.

HELP

The HELP Committee Health jurisdiction encompasses most of the agencies, institutes, and programs of the Department of Health and Human Services, including the Food and Drug Administration, the Centers for Disease Control and Prevention, the National Institutes of Health, the Substance Abuse and Mental Health Services Administration, and (CSAP) Center for Substance Abuse Prevention.

State, Foreign Operations, and Related Programs Subcommittee

This subcommittee has jurisdiction over the budget of the United States Department of State and any Foreign Operations.

Judiciary Committee

In addition to its critical role in providing oversight of the Department of Justice and the agencies under the Department's jurisdiction, the Judiciary Committee plays an important role in the consideration of pending legislation.

<u>United States Senate/House Appropriations Subcommittee on Labor, HHS, Education, Related Agencies</u>

The subcommittee on Labor, Health and Human Services, Education, and Related Agencies is a subcommittee within the Senate/House Appropriations Committee. This subcommittee has jurisdiction over the budget for the United States Department of Health and Human Services.

Appropriations Committee

Responsible for deciding what funding levels every program in the federal government receives.

House Committee on Energy and Commerce

The Committee has the broadest jurisdiction of any authorizing committee in Congress. It legislates on a wide variety of issues, including mental health and substance use as well as drug safety.

House Energy Subcommittee on Health

They authorize the Department of Health and Human Services; the National Institutes of Health, the Centers for Disease Control, SAMHSA, NIAAA, and NIDA.

<u>Financial Services and General Government Appropriations Subcommittee</u>

This subcommittee has jurisdiction over the Office of National Drug Control Policy. This controls the DFC and CARA Enhancement Grants.
